Do you have a wound care clinic in place for your local demographic and where do your referrals come from?

We have a clinic that is predominantly for patients with leg ulceration, however we do see patients with other types of wounds if it requires specialist intervention that cannot be provided by a practice nurse. Our referrals come from our Luton district nurses, nursing homes, practice nurses, GPs, hospices, children's nurses or the local hospital via TVN or vascular and dermatology outpatients departments.
